It was an honour to serve as President of Community Living Chatham-Kent (CLC-K) during the 2021-2022 year.

Working with such a dedicated and talented Board of Directors was a pleasure. Michele Rice, after several years of outstanding contributions, moved on, and Jack Barei was welcomed back to the Board.

I thank the employees, committee members, volunteers, and community partners for their ongoing commitment to this excellent agency.

Our Integrative Partnership with PHSS-Medical & Complex Care in Community, and DeafBlind Ontario Services continued.

Community Living Chatham-Kent underwent an accreditation process with FOCUS Accreditation. Two FOCUS Accreditation validators were onsite November $22^{nd} - 25^{th}$, and another two validators participated virtually. During that week, FOCUS completed twenty (20) interviews (in-person and virtually), reviewed twenty-six (26) files (Board Members, people accessing services, and employees), and visited Stewart Street, Stirling Lane, Llydican, and Children's Respite. While visiting sites, they were able to speak with people accessing services. Prior to the onsite validation, two hundred and ninety-two (292) surveys were sent to various stakeholders including Board Members, people accessing services, employees, families, students, community partners, and funders. CLC-K achieved, with a score of 94.5 %, a four year accreditation for the period of January 2022 – January 2026. CLC-K was the first organization to be accredited using the newly revised 2020 FOCUS Standards.

The property at 91 Grand Avenue East was purchased for the purpose of future development.

CLC-K donated \$1,000 to the non-profit organization 'Nwewnan Sasaang' – Language Nest – Sounds from the Nest Program on Walpole Island which specializes in Indigenous language immersion for early childhood education.

COVID-19 made this past year challenging and I commend the Board Members, people accessing services, and employees for doing their best to keep each other healthy.

I anticipate that the 2022-2023 year will be terrific.

Throughout the 2021-2022 year, Community Living Chatham-Kent (CLC-K) enriched the lives of people who had diverse abilities by providing quality services, and meaningful and inclusive opportunities. We worked in partnership with the Ministry of Children, Community and Social Services, Municipality of Chatham-Kent, St. Clair Catholic District School Board, Lambton Kent District School Board, St. Clair College, Community Living Ontario, Ontario Agencies Supporting Individuals with Special Needs, and businesses.

I offer my sincerest thanks to the Board of Directors for its wisdom and strong leadership, to Jodi Skipper, Lisa Blonde, Lesa Jansen, Mickey Kovacs, Brad Verfaillie, and Angela Corso for their dedication, and to the best employees in Ontario.

The people who accessed services were, and always will be, the agency's number one priority. The Direct Support Professionals provided the finest supports, and their compassion, and commitment were excellent.

There was fantastic collaboration among members of the Senior Management team and OPSEU - Local 148 President Jennifer Ganley, and Past President Wayne Easterbrook.

Minogiizhgad guided the agency in developing a Land Acknowledgement Statement which was implemented at the Annual General Meeting. In July, CLC-K personnel went on a Journey of Learning facilitated by Minogiizhgad. The learning included traditional territory acknowledgement development and a Bkejwanong Tour - First Nation historical waterways tour.

CLC-K underwent a Quality Assurance Measures Compliance Review during the period of February 15th-17th. Katie O'Leary from the Ministry of Children, Community and Social Services did site inspections at Pine Street, Carolinian Place, and Lacroix Street, she reviewed seventeen (17) files of people who access services, six (6) employee files, Board Records, Board Minutes, Serious Occurrence Reports, Fire Safety Plans, Monthly Health & Safety Inspections, and she focused on COVID-19 Preparedness and Prevention. CLC-K did outstanding having no (zero) non-compliances.

It was great collaborating with Roxanna Spruyt, CEO of DeafBlind Ontario Services, and Brian Dunne, CEO of PHSS-Medical & Complex Care in Community. Mellor Murray Consulting did a Review of the Integrative Partnership, and Aileen Murray and Lynn McGeachy Schultz presented the Review to Roxanna, Brian, and me.

CLC-K hosted Mental Health First Aid Facilitator training for multiple agencies at the Park Avenue location. Janna Stawarz, Manager, and Rochelle Stothart, Manager, received their Provisional Instructor status. They became Certified Instructors, and Janna, and Rochelle will be facilitating training to certify agency employees in Mental Health First Aid. CLC-K was fortunate to have an outstanding Wellness Committee in place. The Wellness Committee collected and distributed relevant materials as well as organized events for employees (eg. sunflower challenge).

The CLC-K Christmas Tree Lighting and the Armoury In Lights Christmas Show occurred on December 7th. The Virtual Christmas Concert was on December 16th, and five hundred and thirty-three (533) people clicked the link to view the concert via e-mail, and Facebook. Graceon C., Aiden D., and Jack B. were selected as Jonathan Daniel Stone Fund winners. The Cooking Up Memories 2022 Lottery Calendar sold out and the net revenue was over \$32,000.

Kim R., and Jason W. were the winners of the Rob McLandress Make A Dream Come True Fund, Michelle Bunney received the Joan Olive Risdon Memorial Award of Distinction, and Kathy Dinga, owner of Eli's Breakfast & Lunch, was the recipient of the Joyce M. Carr Champion Award.

In closing, I offer my gratitude to the people, their families, and the employees, as Team CLC-K looks forward to the 2022-2023 year.

FINANCE COMMITTEE REPORT

Community Living Chatham-Kent had an interesting year, but with a successful 2021-22 operational performance.

Increase in Fund Balances of \$705,706 (2020-21 \$917,078).

Increase in Cash & Marketable Securities \$359,271, (2020-21 \$320,427)

Current Assets compared to Current Liabilities (Working Capital) increased \$84,871; Current Ratio 2.00 from prior year of 2.09.

We had a reduction in our Term/Mortgage Loans from \$744,527 to \$673,374, a decrease of \$71,153 in paid principle.

Community Living Chatham-Kent in 2021-22 continued to experience a strong financial performance, and ended in a very healthy Financial Position.

Community Living Chatham-Kent's Administration costs year over year had an increase of 10% (\$110,232) from the prior year. Yet Administration costs as a percentage of total costs were 7.79% (2021-22) versus 7.44% (2020-21) as revenues continued to decrease due to COVID.

Community Living Chatham-Kent had a decrease in base funding within the Ministry funded programs of \$1,200,200; as Day and Respite Programs were significantly reduced due to COVID restraints. This has no impact on 2022-23 funding. Excluding MCCSS programs and Capital Asset funding, Community Living Chatham exceeded budget of \$212,000 by \$145,000 to \$357,000 thru strong returns in the investment portfolio and performance is the Ontario Employment Disability Supports Program.

Other Support Services (Passport); continued its services for the most part through material supports as the COVID impact continued.

The Ontario Disability Supports Program – Employment Supports had another solid performance with Net Revenues of \$180 thousand down versus prior year from \$258 thousand, as revenue decreased \$13 thousand and labour costs increased \$53,000 as staffing levels returned to normal.

In fiscal year 2021-22 while not directly purchasing any homes, we had the completion of our new residential ranch style accessible home. CLC-K entered into an agreement with the Municipality of Chatham-Kent on the construction of a newly constructed residence to be completed in fiscal 2022-23 and finally the purchase of a choice reasonable priced piece of property for future growth.





1.0 Welcome

Zoli Horvath welcomed everyone to the 66th Annual General Meeting and opened the meeting at 6:35 p.m.

A land acknowledgement statement was presented by Ron Coristine to recognize and honor Indigenous Peoples as traditional stewards of the land.

2.0 Congratulatory Messages

Zoli Horvath introduced Mayor Darrin Canniff.

Mayor Darrin Caniff expressed his gratitude to the organization for positively impacting so many people in the community. Darrin was thankful to the staff, leadership and the people who volunteer so much of their time to better our community. He looks forward to seeing everyone out in the community again, as the opening of Ontario continues.

Ron gave special mention to Janice McFadden, who has been critical to the agency in navigating us through the pandemic.

Ron took the opportunity to commend the people in residential homes, for their resiliency and the sacrifices made during the lockdowns.

Ron also extended thanks to Program Supervisor, Mary Harper for her support over the years.

Ron reviewed the Annual Report.

In the opinion of KPMG the financial statements present fairly, in all material respects the financial position of Community Living Chatham-Kent as at March 31, 2021.

Liz Zantingh (Rick MacFarlane) moved that the Audited Financial Statements for the fiscal year 2020-2021 be accepted as presented.
