Working with such a dedicated and talented Board of Directors was a pleasure. Kelly Doyle, and Rick MacFarlane exited the Board after making valuable contributions, and Dr. Kayla Murphy was welcomed to the Board.

In May, the Board approved a new three-year Collective Agreement between CLC-K and OPSEU Local-148.

Community Living Chatham-Kent, the Rotary Club of Chatham Sunrise, and Earthworks Garden Centre partnered to beautify the property, owned by CLC-K, at 91 Grand Avenue. The property became the Salute to Ukraine Rotary Park.

The Board was pleased that MPP Trevor Jones was in attendance at the Annual General Meeting in June.

CLC-K underwent a Quality Assurance Measures Compliance Review during the period of January 2^{nd} – February 2^{nd} . Beverly Howell and Lisa Dickson from the Ministry of Children, Community and Social Services did several site inspections, reviewed thirty-six (36) files of people who access services, fourteen (14) employee files, Board Records, Board Minutes, Serious Occurrence Reports, Fire Safety Plans, and Monthly Health & Safety Inspections. CLC-K did great having three (3) non-compliances, which were corrected immediately.

I congratulate Marie Letourneau, and Angel Nahdee, winners of the Rob McLandress Make A Dream Come True Fund, Zoli Horvath, recipient of the Joan Olive Risdon Memorial Award of Distinction, and Chatham Breakfast House and Grille Churrascaria, winner of the Joyce M. Carr Champion Award.

The agency donated \$1,000 from the Food Truck Crawl to children who had diverse abilities and resided in Ukraine. The money was utilized to purchase medicine and groceries.

I thank the Board Members, employees, committee members, volunteers, and community partners for their ongoing commitment to this excellent agency.

I anticipate that the 2023-2024 year will be outstanding with the people accessing services remaining the top priority.

We worked in partnership with the Ministry of Children, Community and Social Services, Municipality of Chatham-Kent, SCCDSB, LKDSB, St. Clair College, Community Living Ontario, Ontario Agencies Supporting Individuals with Special Needs, and businesses.

I offer my sincerest thanks to the Board of Directors for its wisdom and strong leadership, to Jodi Skipper, Lisa Blonde, Mickey Kovacs, Brad Verfaillie, and Angela Corso for their dedication, and to the best employees in Ontario.

The people who accessed services were, and always will be, the agency's number one priority. The Direct Support Professionals provided the finest supports, and their compassion, and commitment were excellent.

Community Living Chatham-Kent and OPSEU Local-148 agreed to a three year Collective Agreement. I extend my appreciation to Local-148 President Jennifer Ganley, and Past President Wayne Easterbrook.

CLC-K was very sorry for the losses of former Director Lee Ann Mallett, and past Director of Human Resources Lesa Jansen. During the last few years of Lee Ann's professional career, I had the pleasure of working alongside her. In 2014, Lesa was awarded the Making a Difference Award for her contributions to improving the quality of supports provided by Developmental Services professionals throughout Ontario.

Our Integrative Partnership with DeafBlind Ontario Services, and PHSS-Medical & Complex Care in Community continued. On February 14th, Karen Chan facilitated an interactive strategic planning process with the Partnership Oversight Committee and members of the Working Groups.

CLC-K hosted a FOCUS Accreditation Celebration Barbeque. The Optimist Club food-truck offered a delicious lunch, and Ohana Ice provided shaved-ice, and cotton candy. Camryn Dudley did a wonderful job of singing at the event.

On National Truth and Reconciliation Day, the Every Child Matters flag was raised at the Administration Building, 1099 Park Avenue, and 101 Stewart Street. Employees donned orange shirts and at the Administration Building, people observed a moment of silence, and listened to a poem read by Angel N.

CLC-K made a commitment to Equity, Diversity, and Inclusion training for agency personnel. The training will be facilitated by Indu Radhakrishnan.

Janna Stawarz and Rochelle Stothart provided Mental Health First Aid training to agency employees. The Wellness Committee, whose goal was to promote and ensure the physical and mental wellness of employees, had resources available on the wellness drive for employees to access when needed, hosted outdoor yoga, and held draws every other month to spotlight local businesses that focused on health and wellness.

I offer congratulations to Sebastian Campbell, and Thomas Palacios who were selected as Jonathan Daniel Stone Fund winners.

A net profit of \$15,689.80 was raised at the 2022 Golf Tournament held at Willow Ridge Golf & Country Club. The Food Truck Crawl, at the Sons of Kent, raised a net profit of \$24,113.54. The Discover Your Health & Wellness 2023 Lottery Calendar sold out and the net revenue was \$31,867.31.

CLC-K was thrilled to host MPP Trevor Jones, and Ontario Trillium Foundation volunteer Fanny Vavoulis for a recognition event. The agency had received \$6,400 which allowed for the purchase of laptops with accessories to be utilized in the Outward Bound Program.

In closing, I offer my gratitude to the people, their families, and the employees, as Team CLC-K looks forward to the 2023-2024 year.

FINANCE COMMITTEE REPORT

Community Living Chatham-Kent had an exciting and a successful 2022/23 operational performance.

Increase in Fund Balances of \$1,301,136 (2021-22 \$705,706).

Increase in Cash & Marketable Securities \$591,843, (2021-22 \$359,271).

Current Assets compared to Current Liabilities (Working Capital) increased \$490,727; Current Ratio 2.03 from prior year of 2.00.

We had a reduction in our Term/Mortgage Loans from \$673,374 to \$602,878, a decrease of \$70,496 in paid principle. Community Living Chatham-Kent in 2022/23 continued to experience a strong financial performance and a very healthy Financial Position.

CLC-K's Administration costs year over year had an increase of 4.0% (\$42,943) from the prior year. Administration costs as a percentage of total costs were 6.74% (2022/23) versus 7.67% (2021/22) as revenues returned to normalcy from COVID-19.

Excluding MCCSS programs and Capital Asset funding, CLC-K exceeded their budget of \$187,702 by \$278,869 to \$465,571; with a strong performance throughout the non-MCCSS activities.

Other Support Services (Passport), proved continued growth and some movement to higher margin labour services exceeded budget by more than \$86 thousand.

The Ontario Disability Support Program – Employment Supports had another solid performance with Revenues of \$400,000 up from \$375,000 the prior year and costs reduced. In total, ODSP exceeded budget by \$100,000.

The Agency with higher interest revenue was able to more than counter the investment market fluctuations with revenues exceeding budget by \$51,000 and costs savings of another \$10,000. Net favourable to Budget by \$61,000.

During the fiscal year 2022/23 Community Living Chatham-Kent was busy on the construction of a newly constructed owned residence that was completed in April of 2023. Residents moved from a two-story rental into their fully accessible and modern home in April.

CLC-K is hopeful that the past restrictions are now behind us. We should all feel proud, as well as reassured that the agency is operationally stronger, financially sound, and ready to meet the continuing challenges that may come our way. We shall continue to work together to bring ours, and the lives of the people accessing service, increased involvement, as 'Communities are at their BEST, when everyone is participating'.





Ron anticipates a bright future for Community Living Chatham-Kent and is looking forward to a successful year ahead.

4.0 Acceptance of Minutes of 2021 AGM

Stephen asked if there were any errors or omissions in the minutes of the June 29, 2021, 66th Annual General Meeting. There being none, he asked for a motion to approve the minutes as presented.

Cynthia outlined that the statements were audited by KPMG and that there was sufficient information to present the financial position fairly at March 31, 2022. The financial statements are in compliance with Canadian accounting standards for not-for-profit organizations. In the opinion of KPMG the financial statements present fairly, in all material respects the financial position of Community Living Chatham-Kent as at March 31, 2022.

Jack Barei (Kelly Doyle) moved that the Audited Financial Statements for the fiscal year 2021-2022 be accepted as presented.
